Staff Present:

I. Call to Order: Meeting called to order at 6:04 pm by President Darcy Arnold.

II. Absences: See above.

- III. Minutes Review. Motion made by David Lane and seconded by Trevor Harrison to approve the minutes from November with the following changes; "Trevor presents an ask" related to his request to the Montrose County Commissioners. All in favor, motion carried.
- IV. Public Comment: Steve introduced Assistant Director of Finance, Kevin Sowder to the Board.
 - A. Board Emails: Darcy reminded everyone to check your COI emails. Darcy is getting a bunch of compliance emails.
- V. Audit Exit Conference: Postponed until the January Board Meeting as the audit is still not ready to finalize yet. The audit needs to be finished by the end of the week anyway, but it would be better to present once finalized.
- VI. Executive Director's Report:
 - A. Tom opened by wishing the Board Happy Holidays, thanking Darcy for providing dinner for the Board meeting, and Aimee for the logistics. The COI quarterly newsletter and Tom's article from the Daily Press were handed out. Today is Colorado Gives Day we received several donations, around \$1,100 as of the meeting. Tom will keep an eye on it.
 - B. Update on the relinquishment of the HCA license, we're not getting as much consternation as Tom was expecting. Families are coming to us for help figuring it all out though. The process is going relatively well. The changes in service affects 45 clients and about that many staff as well. Our projections are that the relinquishment reduces our yearly income by about \$250k but the expenses go down about \$350k.

Touch of Care HCA might be the only company that is picking up all services we are dropping, perhaps even respite. A plus for any HCA is that the services comes with staff. Pasco only has program approval for CES not SLS, Tom is looking into that because it's just weird. Why they would do one and not the other, especially children since they typically serve adults. We're doing all we can to keep from having a break in service for these clients and their families, as well as our staff.

- C. We are making the shift to new insurance. There were three open enrollment meetings today and one tomorrow. The first underwriter we were looking into came in with much higher rates than expected so we started over with a new underwriter. The second bid isn't as good as the original but it's still \$100-\$125k a year savings from our current plan.
- D. Update on recent meetings:
 - November 14th there was a follow-up meeting with Montrose County HHS, suggested by Sue Hanson. Darcy, Tom, and Steve met with HHS staff and County Manager Ken Norris. Sue Hanson was unable to attend. Basically, the ideas they came up with were talking to HCPF, state legislators, and to ask if we had considered running a mill levy. No word yet on the \$500k ask from Montrose County or on our normal annual ask.
 - November 15th was a phone call with Wells Fargo. Tom also met with Senator Coram. The meeting was positive, and Senator Coram told Tom whatever he needs to champion our agency and system he will do. Tom extended an invitation for the Senator to come out and see what we do, maybe visit Park Place, Thursdays work best for everyone, they haven't been able to connect yet.
 - Steve and Tom had another follow-up phone call with HCPF. After looking over everything there is no help they can provide other than perhaps through the budget process. Bonnie Silva stated that somehow the 9 other rural CCBs have better adjusted to the changes than we have, and they are doing fine. That may be HCPF's perspective but that is not what we hear from the other rural boards.
 - Thursday November 12th Tom will be attending a JBC/HCPF briefing. Afterwards Tom and his counterpart from Steamboat Springs have a meeting with Senator Rankin to update him and see if he has any input.
 - Darcy announced that we have a Dec 17th meeting with the Delta County Commissioners.
- E. Mountain Film fundraiser ended up with \$8,000 in net proceeds so \$4,000 for both entities. It went well.

VII. Committee Reports

A. Finance/Audit Committee:

a. October finances, Revenue continues to hold to budgeted amounts. Budgeted expense is a bit under budget but should be with \$15,000/month increase in the monthly salary due to 1/1/20 increase in minimum wage. Cash is holding out fairly well. Bottom line for October, while we lost \$33k in October, the good news is for the first four months of the year we are breaking even. Also, in January the GRSS Medicaid rates will be going up (projected increase of \$18.5k/month) so that will help mitigate some of the new costs. Working capital is hanging in there. It has taken a big hit this year because of the two notes payable moving into current liabilities. When those notes are renewed the working capital will look better. October facility items: new windows at Canyonview and their roof needed to be reattached; Garnet needed some re-

- plumbing help in the crawl space\basement area; Bradford had a water main break on our side of the tap that needed repair and in November their furnace quit functioning and a new one is being installed; Currently, Vista View had a sewer smell so Maintenance looked in the crawl space and there was a sewage problem. Access is extremely limited so we may have to tear up the floor to access. Still getting a game plan together. David Lane moved to approve October expenses, seconded by Carolyn Rettig, all in favor. Motion carried.
- b. Conversation about the staff bonus: Tom proposed a \$25.00 Christmas bonus for staff as we did last year. David Lane moves to vote on a potential employee bonus, seconded by Dr. Dwyer. Discussion ensued. Although the \$6,800 is relatively minor, there is concern about the bonus because it sends a mixed message about the agency's dire financial straits. No bonus sends a powerful statement to outsiders by letting them know we've had to cut even the smaller benefits. A counter-view is that because the employees have worked so hard to help out with holding expenses down, they should be rewarded. Several members expressed that while it really is a horrible thing to have to do, a bonus really can't be approved. Tom thought that staff will understand. Vote was for no Christmas bonus this year. Tom encouraged Board members to attend the Park Place and Aspen Crest parties to thank staff personally.
- c. As another small way to save some money, Board material like minutes and agendas will now be sent out electronically rather than paper.
- B. PR/Fund-Raising Committee: Darcy wants to give some good news about the "No Event Fundraiser" for the local match of the new CDOT vans. Highly successful, with an excess of \$22k over the \$40k needed for the match. The "No Event Van Fundraiser" is ongoing through January 2020. End of year fund raising letters going out, so they need to be back to us by Monday for mailing. A mailing list was passed around so the Board can make a note of who they're approaching. Trevor must recuse himself from the individual fundraising letters per his employment stipulations.



I love this time of year but also hope for another very snowy winter (other than when I have to drive to Denver) to keep working on our persistent drought. Keep your fingers crossed.

As usual, there has been a lot going on around our agency, and I wanted to provide some updates. First of all, I want to thank all of you who were able to attend our Annual Meeting on October 9th, and I hope you enjoyed meeting and hearing from Christiano Sosa from the Arc of Colorado. The performance by Joyful Sounds was great fun as always, and it's been a very long time since I've done the Hokey Pokey! I encourage you to read a copy of our Annual Report that was distributed at that meeting. I think you will find it interesting and informative. I also want to thank all of you who took part in the process to select the 2019 -2020 Community Options Employee of the Year. We had 12 employees nominated this year, all of whom are very worthy of this honor, and I'd like to congratulate each of them. The nominees were: Kandi Connell, Brandi Goddard, Janice Jones Elliott, Gaylan Largent, Shelley McKenzie, Laura McLagan, Jean Mullins-Seth, Midge Pruitt, Randi Purdue, Shay Sickles, and our two cowinners, Marilyn Fick and Jessica Hoover! Please join me in congratulating Marilyn and Jessica, and all those people who were You are truly representative of nominated. our many, many terrific employees.

I also wanted to let you know that on November 9th we held another very successful Mountainfilm on Tour event. We packed the Pavilion to overflowing, and I wanted to thank those of you who were able to attend. Thanks to Bruce, Mary, and Paul for handing out programs. Special thanks also to Jim Womeldorf for all of his work on this event that raises funds for our agency and also brings lots of positive attention and public awareness.

On a systems level, work continues on a bazillion things, many of which involve efforts to stabilize our financial situation in the face of years of enrollment attrition, increases in the minimum wage, and exorbitant health insurance costs, with only minimal increases in our Medicaid rates to offset those increased

expenses. On the "increasing revenue" side of this equation, we have begun a campaign of selling logos on our vehicles and other fund-raising activities, and we are involved in a whole series of meetings with officials at the Dept. of Health Care Policy and Financing, as well as local County Commissioners and City Councils seeking additional financial support. On the "decreasing expense" side of this predicament, we have two major efforts in the works. First of all, as you are all aware, we are in the process of negotiations to change our health insurance to a self-funded, reference-based payment approach that will maintain our current (or perhaps even better) coverage at what we hope will be a considerable savings to employees and the agency. proposed to go into effect 1/1/20, so stay tuned for information on open enrollment meetings.

The other major undertaking is that of relinquishing our Class B Home Care Agency License effective 12/31, and the cessation of providing Personal Care, Homemaker, and Respite services through both our SLS and CES Medicaid Waivers. This decision has not come easily and relates to many complicating factors that are outside our control. We understand these services are very important to families and the people receiving those services, so we are in the process of contacting community Home Care Agencies to transfer those services. So far, the response from those other agencies has been very encouraging, so we are hopeful to minimize the impact and disruption on families and providers.

Oh, and for the second year in a row, we're also submitting another Colorado Dept. of Transportation (CDOT) grant to try and get two new vehicles. The three vehicles that we were successful in obtaining through last year's grant should be arriving sometime in December or January, so get ready for some beautiful new rides!

Apart from all of this, however, the Holiday season is upon us yet again, and Community Options is a very special place in which to celebrate. It's time to take a breath and remember that we have many reasons to be grateful again this year, and all of the events around our agency offer many opportunities to get in the holiday spirit. The Thanksgiving and Christmas celebrations at our facilities, and the dances and holiday meals are all great chances to celebrate with our co-workers and the people we support. whether you celebrate the birth of Christ, or Hanukkah, or Kwanzaa, the Winter Solstice, or simply the completion of one year and the coming of another, here's wishing each of us a joyful, grateful, and peaceful Holiday season. Thanks for another year of hard work and caring on behalf of the people we serve, and may we all have a productive and successful 2020. Until next time, be safe, work hard, have some fun, and Happy Holidays!



The middle group with Jean, Joseph, and Autumn



SLS has discovered very empowering ways to use Mentorship services. Mentoring clients to bring them to the next level to support their independence. One of our clients has been doing so well at keeping their home clean, their laundry washed and folded and put away and their dishes done up, the client was excited to know they will be participating to maintain their independence. By SLS offering Mentorship the SLS staff will come alongside to instruct, model, advise clients to support and help clients to advocate for themselves to meet criteria for home inspections by their landlords, and making decisions for their wellbeing, as well as providing understanding care instructions and promoting the client to advocate for themselves while seeing their care provider.

Did you know families can provide Supported Community Connections for their family members in services with SLS? The change of services like respite (giving the primary caregiver a break) to SCC (meeting members in the community) shows in some cases this service would better accommodate the families and clients to access those functions outside of the home while out in the community.
